## The Survey Says ....

Thank you to all the CPEA members who took the time to complete the CPEA Negotiations Survey a few months ago. The data from this document will then become the guiding principle to help our Negotiations Team maintain a clear, consistent focus throughout the negotiations process from start to finish. The Survey prioritized the top areas of focus for this year's round of negotiations: (1) Salary and Benefits (2) Work Load and Time Constraints (3) Working Conditions (4) Planning Time/Classroom Conditions (5) Job Security and Stability.

#### Money . . .

As always, our Survey revealed salary and benefits as our members' number one priority by a long shot. Only once, ten years ago and for the first time ever, did a topic replace salary as the proverbial expectation from our membership. That year, working conditions, the unnecessary amount of TBTs specifically, came in at number one. Since then, we have continued to make advances in teacher prep time with each subsequent contract. As a rule of thumb, if we can create and successfully advance language in <u>three</u> of the <u>five</u> identified areas of membership concerns in any particular negotiating year, we consider it an extremely successful round of negotiations.

### The Negotiating Team . . . .

The following CPEA members will be representing our Association with pride, diplomacy and perseverance:

**Randy Bifolchi** – (McKinley High School) This year will be Randy's fifth contract negotiations session, spanning the course of the last twelve years. Highly experienced with a strong sense of logic and the negotiations process, Randy is instrumental in keeping a clear focus on the data and feedback provided by membership as his driving force. Randy has earned the nickname, "The Closer" for his ability to recognize the appropriate time a deal or compromise is within reach.

Her questions are thought provoking, and lead us in the right direction. She is a valuable asset in the caucus room when we are considering a proposal or creating a counter offer.

**Jennifer Schott** – (**Worley Elementary**) Jennifer is the glue that keeps the negotiating process neat, tidy, and organized. She is blessed with an incredible ability to record, with maximum accuracy, the most vital aspects of the process from start to finish. With mountains of data, information, proposals, counter proposals, and keeping track of <u>all</u> verbal statements made, she somehow keeps it all straight. This is Jennifer's  $4^{th}$  contract, and she is truly the unsung hero.

**Lynne Watson** – (**CPEA Vice President**) This will be Lynne's sixth round of negotiations as the chair of the committee.
